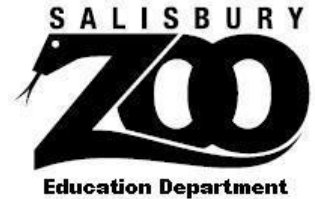




# Wild Party RULES AND REGULATIONS



1. The user group guarantees that proper adult supervision will be provided at all times and that all group members shall comply with the rules and regulations stated.
2. No smoking is permitted in any Zoo buildings or inside of the zoo gates.
3. Supplies: It is the responsibility of the user group to provide paper products, food and decorations needed.
4. No balloons due to the chance of choking hazards, if balloons accidentally escape and get into enclosures.
5. No piñatas are permitted due to the lack of space and inadequate place to hang one.
6. Decorations can be placed on the glass portion of the doors, countertops and tables only. Nothing can be attached to the walls or ceiling.
7. Before departure, the user group is responsible for cleaning the facility. This includes vacuuming, wiping down kitchen surfaces, counter tops and tables and putting out trash.
8. The using group will be assessed full replacement value for any equipment or property that is broken, lost, damaged or rendered useless.
9. Animals within the building are not to be fed anything by party attendees. There should be no hands on or in tanks and cages of animals within the building.
10. A non-refundable \$30 deposit is required within one week of making reservation to hold reserved date. Checks should be made payable to: Salisbury Zoo and the balance is due a minimum of 24 hours in advance of the party. If paying via Credit card, payments will be run at the time of the party, but all necessary information will be collected at the time of the reservation to hold the party reservation.
11. The user group is responsible for notifying the Zoo staff member in the event of any emergency.
12. The Zoo staff member will remain in the Education building for the entire time of the party.
13. The program will take place regardless of weather.
14. The user group will not be allowed in the building prior to the rental time and is expected to be clean up and all supplies removed by the end of the rental time.
15. The user group may not exceed 40 people total according to fire code.
